## **NEW BUSINESS:**

The Council approved Title IV Non Discrimination Agreement from The Georgia Department of Transportation. Title VI of the civil acts provide that no person in the United States shall, on the grounds of race, color, national origin, be excluded from participation in, be denied the benefits of or otherwise subjected to discrimination under any program or activity receiving federal financial assistance. The agreement was approved upon a motion made by Councilmember Scott Harper, seconded by Councilmember Junior Hardy. Motion carried.

The Council approves the Intergovernmental Agreement for 2018 Banks County TSPIOST. If this passes, the city would receive \$969,530 over a period of 5 years. Banks County will get 75% and the remaining 25% will go to the cities. Motion to approve the agreement was made by Councilmember Kathleen Bush, seconded, by Councilmember Richard Parr. Motion carried. Copy of percentage disbursements attached to minutes. These funds if passes will be used for resurfacing highways and equipment.

## NO LIBRARY REPORT:

## **PUBLIC INPUT:**

Mr. William Roberts, 447 Sears Drive, Maysville, GA addressed the Council with complaints about a neighbor being in violation of the Maysville Land Use Management Code.

Mr. Robert stated that Mr. Harris is registered with the Secretary of State's Office under the name of Harris Grading and Construction Company, with the address of 463 Deer Run, Maysville, GA.. He went on to state that he is parking equipment and trucks on his property.
