Regular Council Meeting

The Mayor and Council met on Monday May 14, 2018, 7:00 p.m. at 4 Homer Street for the Regular Monthly Meeting.

**Present:** Mayor Richard Presley, Councilmember's Kathleen Bush, Richard Parr, Scott Harper and Junior Hardy, City Clerk Barbara Thomas was not present.

Mayor Presley opened up the meeting with the invocation and the pledge of allegiance to the flag.

**APPROVE MINUTES:**

The minutes if March 5, 2018 Regular Meeting and March 15, 2018 Special Called Meeting was approved upon a motion made by Councilmember Scott Harper, seconded by Councilmember Richard Parr. Motion carried.

**NEW BUSINESS:**

The Council approved an Intergovernmental Agreement from Jackson County to do the city elections. This was approved upon a motion made by Councilmember Kathleen Bush, seconded by Councilmember Scott harper. Motion carried.

A Rental fee of \$50.00 (per 3 hours), \$75.00 (per 6 hours) and all day (\$100.00) was approved for each of the Pavilions and a rental fee of \$200.00 per day for the Amphitheater. This was approved upon a motion made by Councilmember Richard Parr, seconded by Councilmember Kathleen Bush. Motion carried.

A 50 cents increase was approved for garbage pickup starting in July. This increase will go from \$14.50 per can to 15.00 per can per month. This was approved upon a motion made by Councilmember Scott Harper, seconded by Kathleen Bush. Motion carried.

The bids were opened for the two vehicles that were advertised. The highest bidder on the 2009 Charger was Jose Rivas, \$1500.00.

The bids on the 2006 Crown Vic was Tim Adams at 1200.00. When he was notified he said he did not have the money so it was awarded to the next highest bidder Jerry Parr at \$1125.00.

The bids for the cars were approved by Councilmember Scott Harper, seconded by Councilmember Kathleen Bush. Motion carried.

The Council approved the bid of 1250.00 from American Tank Company to clean the water tank. The motion approve the bid was made by Councilmember Scott Harper, seconded by Kathleen Bush. Motion carried.

An Agreement was approved from DNR to restock the pond with fish at the New City Park at 48A Homer Street. The pond will be closed from November 2018 to May 1 2019. Motion to approve was made by Councilmember Richard Parr, seconded by Councilmember Scott Harper. Motion carried
