

**March 4, 2019**

**REGULAR MEETING**

The Mayor and Council met on Monday, March 4, 2019, 7:00 p.m. at 4 Homer Street for the Regular Monthly Meeting.

Present: Mayor Richard Presley, Councilmember Kathleen Bush, Junior Hardy, Richard Parr, Scott Harper, City Administrator/City Clerk Barbara Thomas.

The Mayor opened up the meeting with the invocation and pledge to the flag. The invocation was given by Mayor Richard Presley.

The minutes of February 4, 2019 was approved as read by a motion made by Councilmember Scott Harper, seconded by Councilmember Kathleen Bush. Motion carried.

**LIBRARY REPORT:**

Melanie Weatherby, Manager of the Maysville Library gave a report of the most recent activities of the Library. She also asked permission to have the annual Library egg hunt at the Maysville City Park on Saturday, April 13, 2019, starting at 10 a.m... The Friends of the Library will have a fundraiser that consist of serving BBQ or Hot Dogs. All proceeds will go to benefit the Library. The Mayor and Council commended Mrs. Weatherby for the good work that she and Jordan are doing at the library.

**NEW BUSINESS:**

The upcoming Fishing Rodeo Event was discussed by the Council. The contact person for the event will be Councilmember Richard Parr. A motion was made by Councilmember Richard Parr, seconded by Councilmember Scott Harper to set the date of the event on May 11, 2019, 9-1 p.m... Motion carried.

The Council accepted the resignation of Zoning Board Member Bobby Jones. Mr. Jones resigned due to some health issues. One application (Robert Goodwin) was reviewed for the position. The Council chose to table the issue until next month's meeting to give more time to take additional applications.

The Council came up with a list of roads that need to be paved. The list was prioritized beginning with the streets that needs paving the most. Copy of List attached. The LMIG money plus the 30% match will be used first to pay for Newton Street \$17,750.00 and Hoke Street \$40,400.00. The remaining balance will be paid out of Jackson County SPLOST #6.

**OLD BUSINESS:**

The Mayor and Council discussed the drainage problem at 224 Red Oak Drive. Pictures of the area was given to each Councilmember. Upon discussion a bid was received from Dale Construction to cut a ditch for the water to run through the culvert pipe. Cost estimate from Dale Construction was \$2500.00. With this discussion this is still no guarantee that this will fix the problem. Councilmember Kathleen Bush asked the Mayor and Council if she could go to the Banks County Board of Commissioners and ask for assistance in helping with this road. She stated that "We the citizens of Banks County pay high county tax and receive no benefits from them." Councilmember Bush will report back to the Mayor and Council at the March workshop meeting on the 28<sup>th</sup>.

Signs were discussed for the North and South side of the city limits and also the Maysville City Park. The Council will be in touch with Mr. Ronnie Angel about designing a sign for those areas.

The meeting adjourned at 7:55 p.m...
