REGULAR MEETING OCTOBER 5, 2020

The Mayor and Council for the City of Maysville met on Monday, October 5, 2020, 7.00 p.m. at 4 Homer Street.

Mayor Presley opened up the meeting with the invocation and pledge of allegiance to the flag. The invocation was given by Mayor Richard Presley.

NEW BUSINESS:

Mayor Presley stated that a Public Hearing had been held prior to this meeting and the Planning Board had recommended that the requested Variance at 145 Hogan Street was not necessary due to the lot being considered as a non-conforming lot and grandfathered in. The code book was amended in 2007 and anything in place prior to then be considered as grandfathered in. A motion was made by Councilmember Scott Harper, seconded by Councilmember Junior Hardy to approve the lot (0.48 acres) without a Variance being necessary. Motion carried.

Vance Holified spoke regarding the storage trailers at 341 Sears Drive. Ms Fawbush was sick and unable to attend. The storage containers were approved by the Planning Board based on them applying for a Building Permit from the city. They will be building a barn over the containers. Based on the above information from the Planning Board it was approved by the Mayor and Council.

Mayor Presley asked that a motion be made to amend the General Fund budget due to the city receiving \$110.087.18 Cares Act money. The motion to approve the amendment was made by Councilmember Scott Harper, seconded by Councilmember Kathleen Bush. Motion carried.
