The Mayor and Council meet on Thursday, September 23, 2021, for the regular monthly meeting at 4 Homer Street.

Present: Mayor Richard Presley, Councilmembers Kathleen Bush, Junior Hardy,

Richard Parr, & Scott Harper, City Administrator Barbara Thomas.

Citizens present: Vance Holifield, Ryan Moore with True Blue's innovative.

The Mayor opened the meeting with the invocation and pledge of allegiance to the flag.

Ryan Moore with TrueBlue's innovative School Zone Program was present to discuss his program with

the Mayor and Council. Copy attached. He would like to do another study and come back with the results at the next Council Meeting.

Mayor Presley tables the bids for the equipment trailer until next month's meeting.

The installation of the audio conduit at the Amphitheater and Pavilion was approved as presented. Cost was \$1,750.00. This was approved upon a motion made by Councilmember Richard Parr, seconded by Councilmember Scott Harper. Motion carried.

Mayor Presley asked that the three bids for replacing the roof at the library be tabled until next month. The Council wanted more time to compare the bids before a decision was made.

Dale Construction presented an estimate of \$4,300.00 to repair the washout creek bank on Maywood Court with 36 tons of grouted Riprap. Mayor Presley asked that this be tabled until next month's meeting to give time to review other ways of repairing it.

Dale Construction turned in an estimate to repair Freeman Drive, cut and remove asphalt, excavate, and haul off materials. He will backfill and compact with clean material and pour concrete at a cost of \$3200.00. This was approved as presented upon a motion made by Councilmember Scott Harper, seconded by Councilmember Richard Parr. Motion carried.

Banks County Board of Commissioners submitted a revised cost estimate of \$3,860.00 for striping West Ridgeway Road (middle and side of road). This was approved upon a motion made by Councilmember Richard Parr, seconded by Councilmember Scott Harper. Motion carried.

An estimate was received in the amount of \$12,819.00 from Real Time Video to install Honeywell hbd4pr2 which is a fully featured IP camera system at the Maysville City Park. The Mayor asked that this be tabled until next month's meeting for questions from the council.

ACNS presented an estimate for the annual Meraki Firewall Support System \$569.00 annually. This was approved upon a motion made by Councilmember Richard Parr, seconded by Councilmember Kathleen Bush. Motion carried.

ACNS presented an estimate for the annual Computer Consulting Agreement. This was approved upon a motion made by Councilmember Richard Parr, seconded by Councilmember Kathleen Bush. Motion carried.

The Maysville Autumn Leaf Festival was discussed and the possibility of having a float.

Mr. Vance Holifield was present to talk with the Council about Commercial Property being located in Residential areas and how the city needs to address that. The City Attorney will be contacted and will advise the city how to approach that.
