**A proposal for Independent Auditor Services, Mr. Keith Waters with Waters and Morris was approved to do the audit for 2020 and 2021 at a rate of \$10,900.00 annually. Woody McNair with Hawkins and McNair had some health problems and was unable to complete the audits. **Approval was made to purchase new locate equipment for locating water lines and Cemetery lots. **Approval was given to renew the Probation Supervision Services Contract. There were no changes made to the contract. The motion to approve the contract as presented was made Councilmember Scott Harper, seconded by Councilmember Junior Hardy. Motion carried.**

**City Attorney Abbott Hayes, Jr with Hulse, Oliver and Mahar will be increasing his rates effective January 1, 2023, from \$150.00 an hour to \$175.00 an hour. This was approved upon a motion made by Councilmember Scott Harper, seconded by Councilmember Kim Wilmoth. Motion carried.**
