Council Meeting August 14, 2023

The Mayor and Council for the City of Maysville met on Monday, August 14, 2023, at 4 Homer Street.

Present:

Mayor Richard Presley, Councilmembers Kimberly Wilmoth, Junior Hardy, Richard Parr and Scott Harper, City Administrator/City Clerk Barbara Thomas.

Invocation and Pledge:

Mayor Presley opened the meeting with the invocation and Pledge of Allegiance.

Minutes:

The minutes of June 5, 2023, June 19, 2023, June 29, 2023, and July 3, 2023, were approved as read by a motion made by Councilmember Richard Parr, seconded by Councilmember Scott Harper. Motion carried.

The three bids submitted for the repairs to the Gazebo were opened. The lowest bid was from Blackstone Contracting, LLC, \$4,074.12. A motion was made by Councilmember Richard Parr, seconded by Councilmember Kimberly Wilmoth to approve the bid of \$4,074.12 from Blackstone Contracting, LLC. Motion carried.

The bids for the Public Works building on Ellison Street were tabled to gather more information.

A request was made to appoint Susan McLeish as the new Board of Trustee for the City of Maysville. She will be replacing Kimberly Wilmoth.

The estimates for the pallet trucks were reviewed and put on hold pending a donation of a manual set donated by Laura White.

The 2 estimates for a dump trailer to haul brush were reviewed. The bid from Hooper Trailer Sales, Inc. \$11,175.00 was approved upon a motion made by Councilmember Scott Harper, seconded by Councilmember Richard Parr. Motion carried.

An additional amendment was made to the Land Use Management Code Book and was approved upon a motion made by Councilmember Richard Parr, seconded by Councilmember Scott Harper. Motion carried. Copy of amendment attached.

Mayor Presley gave an update on the Eagle Scout project. He would like to store the supplies behind the DDA building on North Main Street. The Council had no objections to storing the supplies there.

The September Council meeting will fall on Labor Day and will be rescheduled later.

A public hearing will be held on Monday, August 21, 2023, at 6 p.m. to discuss the 2023 mill rate for both Jackson 0.264, and Banks County 0.640.

There was no report from the Planning and Zoning Board due to Ken Outcalt not being present.
