## AN ORDINANCE OF MAYOR AND COUNCIL OF THE CITY OF MAYSVILLE, GEORGIA TO REGULATE ENGINE BRAKES WITHIN THE CITY, ESTABLISH PENALITES FOR VIOLATIONS AND FOR OTHER PURPOSES.

**WHEREAS**, excessive and disturbing sound is a serious hazard to the public health and welfare, safety and quality of life; and

**WHEREAS**, the City of Maysville finds that the unregulated use of engine brake devices in the City jeopardizes the continued peaceable and quiet nature of the City, and the use of such devices without justification creates excessive noise harmful and otherwise detrimental to individuals and to the community on the enjoyment of life and in the conduct of business; and

**WHEREAS**, the City of Maysville is authorized to regulate the operation of motor vehicles; to define a nuisance and provide for its abatement; and to provide for the general health, safety, and welfare by definition, regulation, and prohibition of any act, practice, conduct, or use of property detrimental to the health, welfare, and safety of the City's inhabitants.

**NOW, THEREFORE, BE IT RESOLVED AND ORDAINED** by the Mayor and Council of the City of Maysville, by the lawful authority vested in them, that Chapter 42 is hereby amended as adding the following:

## SECTION 42-200 Engine brakes.

(1) No person shall operate or cause to be operated a motor vehicle and utilize an unmuffled engine brake or other similar engine compression retarding devices to slow or stop the vehicle, except in an emergency situation to avoid imminent danger to a person or property.

(a) An "engine brake" for purposes of this ordinance is a device that retards the motion of a motor vehicle by using the compression of the motor vehicle engine.

(b) The Mayor, or the Mayor's designee, is authorized to place signs along the roadways at the corporate limits of the City stating "Unmuffled Engine Brakes Prohibited" and citing this Ordinance.

(c) This ordinance does not apply to emergency response vehicles operated by a government entity.

(2) No person shall operate or cause to be operated any motor vehicle unless the exhaust system of such motor vehicle is:

(a) Free from defects which affect sound reduction;

(b) Equipped with a muffler or other noise-dissipative devise; and

(c) Not equipped with any cutouts, bypass, or similar device.

(2) Any person violating this Ordinance shall be punished by a fine not to exceed \$1,000.00.
