h. DDA Property

The deed for 2 properties for DDA is ready for the attorney to file. Mayor Presley will work with the attorney on the Brevard lot on the deed.

II. New Business

a. Gary Adams Property

Gary Adam has property on Deadwyler Road that he is proposing to sell. Zane Chris his realtor is working with the buyers realtor. The buyers want to work with the city on what type of business would be most suitable for the city. They would like to set up a meeting to discuss any obstacles or opportunities.

III. Matters from Mayor & Council

a. Peddler License

It was brought to the council's attention that the Mobile Food Vendor/Peddle License Ordinance does not have anything for door-to-door sales in it. They would like to bring that back to the council to be amended.

b. Library Hours

There has been a complaint about the library closing at 2pm on Wednesday by a citizen. At this time, we do not have staff to extend hours beyond what they are open.
