SPECIAL TAXING DISTRICT ORDINANCE

OF

THE TOWN OF MAYSVILLE, GEORGIA

WHEREAS, there exists a need within the portion of the Town of Maysville, Georgia located within Banks County to create a special district to provide for fire protection and to authorize the levying of a tax on property lying within said territory for said fire protection;

THEREFORE, BE IT RESOLVED by the City Council of the Town of Maysville, Georgia that the following Ordinance is hereby adopted:

SECTION 1

There is hereby created the Anderson Fire District which shall encompass an area composed of all that territory contained within the following description:

All that certain area of property located in Banks County, Georgia which is now or may hereafter be located within the town limits of the Town of Maysville, Georgia.

SECTION 2

The Anderson Fire District is created for the purpose of affording fire protection within the territory comprising said district, and the Maysville City Council shall carry out the governing of said special district.

SECTION 3

The Anderson Fire District having been created herein for the purpose of affording additional fire protection for the territory comprising this district, the City Council shall have the authority to levy a tax on all taxable property within said territory which shall not be more than 3 mills nor less that ¼ mill. The City Council shall each year set the millage rate for the district at the same time as other ad valorem tax millage rates are set and shall levy and collect this tax upon all taxable property in the incorporated area
