ORDINANCE NO. 2015- 002

AN ORDINANCE TO INCREASE THE SALARIES FOR THE MAYOR, MAYOR PRO TEM, AND COUNCILMEMBERS OF THE CITY OF MAYSVILLE, GEORGIA PURSUANT TO O.C.G.A. § 36-35-4; TO PROVIDE A SALARY FOR THE MAYOR OF \$4,800.00 PER YEAR AND THE MAYOR PRO TEM OF \$2,600.00 PER YEAR; TO PROVIDE A SALARY FOR EACH COUNCILMEMBER OF \$2,400.00 PER YEAR; TO PROVIDE FOR PAYMENT OF EXPENSES OF \$50.00 PER DAY FOR OVERNIGHT TRAVEL; TO REPEAL CONFLICTING PROVISIONS AND FOR OTHER PURPOSES.

WHEREAS, the City Council of the City of Maysville, Georgia, is authorized by O.C.G.A. § 36-35-4, to enact an Ordinance setting the salary for the Mayor, Mayor Pro Tem, and each Councilmember of the City Council and

WHEREAS, the proper administration of the City necessitates a sacrifice of time and effort, for which, the Mayor and each Councilmember should be compensated;

NOW, THEREFORE, it is hereby ordained by the governing authority of the City of Maysville, Georgia, and it is hereby ordained by the authority of same, as follows:

Section 1. COMPENSATION.

The Mayor shall receive compensation of \$4,800.00 per year, the Mayor Pro Tem shall receive compensation of \$2,600.00 per year, and each Councilmember shall receive compensation of \$2,400.00 per year. In addition, the Mayor, Mayor Pro Tem, and

Councilmembers shall receive Fifty Dollars (\$50.00) in expenses for each night away from home on Council business.

Section 2. EFFECTIVE DATE.

The Ordinance is hereby adopted and effective upon passage, with the salary increase to become effective upon the first day of January, 2016, the public health, safety, and general welfare demanding it.

Section 3. REPEAL OF CONFLICTING ORDINANCES.

Ordinances that are in conflict with this Ordinance, are repealed to the extent of the conflict.
