# ORDINANCE NO. 8-00

AN ORDINANCE TO ADOPT A REVISED SCHEDULE OF FINES FOR THE TOWN OF MAYSVILLE, GEORGIA; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

All ordinances and parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

## Section 3. <u>SEVERABILITY OF PARAGRAPHS.</u>

If any portion of this ordinance shall be invalid or unconstitutional, such invalidity or unconstitutionally shall not affect or impair the remaining portions unless it-elearly appears that other parts are wholly and necessarily dependent upon the part held to be invalid or unconstitutional.

# Section 4. <u>EFFECTIVE DATE.</u>

The effective date of the zoning classification imposed by this ordinance shall be July 11, 2000, upon passage.
