ORDINANCE NO. 8-00

AN ORDINANCE TO ADOPT A REVISED SCHEDULE OF FINES FOR THE TOWN OF MAYSVILLE, GEORGIA; TO REPEAL CONFLICTING ORDINANCES; TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Town Council of Maysville, Georgia as follows:

Section 1. REVISED SCHEDULE OF FINES.

That from and after the passage of this Ordinance the Schedule of Fines attached to this Ordinance as **Exhibit "A"** and by this reference incorporated herein and made a part hereof is hereby adopted as the Schedule of Fines to be used in the Municipal Court of the City of Maysville.

Section 2. REPEAL OF CONFLICTING ORDINANCES.

All ordinances and parts of ordinances in conflict herewith are hereby repealed to the extent of the conflict.

Section 3. SEVERABILITY OF PARAGRAPHS.

If any portion of this ordinance shall be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect or impair the remaining portions unless it clearly appears that other parts are wholly and necessarily dependent upon the part held to be invalid or unconstitutional.

Section 4. EFFECTIVE DATE.

The effective date of the zoning classification imposed by this ordinance shall be July 11, 2000, upon passage.
