ORDINANCE NO. 9-13-04- ~

AN ORDINANCE TO GRANT A VARIANCE TO THE PROVISIONS OF THE ZONING ORDINANCE OF THE TOWN OF MAYSVILLE, GEORGIA BY CHANGING THE BUILDING SET BACK REQUIREMENTS OF A PARCEL OF LAND OWNED BY JAMES T. O'KELLEY AND BEING .18 ACRES, MORE OR LESS, AND LYING AND BEING IN BANKS COUNTY, GEORGIA, AND AS DESCRIBED ON SURVEY BY VENABLE BROTHERS RECORDED AT PLAT BOOK 5, PAGE 31 OF THE BANKS COUNTY RECORDS AND INCORPORATED HEREIN BY REFERENCE, AND MADE A PART OF THIS DESCRIPTION FOR THIS ORDINANCE, TO PROVIDE FOR SEVERABILITY; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

BE IT ORDAINED by the Town Council of Maysville, Georgia as follows:

Section 1. <u>VARIANCE GRANTED WITH CONDITIONS.</u>

That from and after the passage of this Ordinance the following described lands shall be granted a variance to the building set back requirements of the zoning ordinance of the Town of Maysville to permit a front set back of fifteen (15) feet and side and rear set backs of five (5) feet.

Legal Description.

See Exhibit "A" attached hereto and by this reference made a part hereof.

Section 2. <u>SEVERABILITY OF PARAGRAPHS.</u>

If any portion of this ordinance shall be invalid or unconstitutional, such invalidity or unconstitutionally shall not affect or impair the remaining portions unless it clearly appears that other parts are wholly and necessarily dependent upon the part held to be invalid or unconstitutional.

Section 3. <u>EFFECTIVE DATE.</u>

The effective date of the variance permitted by this ordinance shall be September 13, 2004, upon passage.
