MAYSVILLE CITY RECORDER'S COURT

(Chapter No.1:
General Provisions

Section 1-8 General Penalty: Continuing Violation: Adjudging
Fines and Imprisonment:

It shall be unlawful for any person to violate or fail to comply with provisions of this Code and where no specific penalty is provided therefor, the violation of any provision of this Code shall be punished by a fine not exceeding Five Hundred Dollars (\$500.00) or imprisonment for a term not exceeding Ninety (90) days, or by both such fine and imprisonment, or by any combination thereof.

Each day any violation of any provision of this Code shall continue, shall constitute a separate offense of said Code Provision (ORD. No. -82-_____, _____ day of _____, 1992.

SECTION 1-9 Judgments and Sentence to Run Consecutively:

All judgments and Sentences imposed and ordered by the Recorder's Court of the City of Maysville shall run consecutively unless otherwise specifically provided by the Recorder in such judgments and sentences.
