I. Old Business

a. EMI Update

Chip McGaughey gave an update on well 5. Chip received a quote from the hydrogeologists Emory and Garrett for their services hourly not to exceed \$3,500.00. They would like to install a transducer in the well to monitor the water level. Chip received a quote from Zile Technology for \$4,689.00 that includes installation. This transducer will connect to the existing telemetry system. Chip was asked to research new well locations, he will look into quotes for hydrogeologists.

b. Lighting Update

Georgia Power has returned a quote for the city park; we will get back with them on the possibility of existing underground power being at the park. Georgia Power is waiting on approvals for the Veterans Park before they send the photometric map over.

c. Veteran Park Wall and Stairs

We have one quote but will post it to get more.

d. Signs for City Buildings

The city has the pictures of the signs designs for City Hall, Police Department and the Library.

e. DDA Beautification Project Update/Dates

The DDA has a downtown beautification project planned in Veteran's Park on Tuesday, May 6th at 9am to plant flowers and trees.
