AN ORDINANCE TO AMEND THE CODE OF ORDINANCES FOR THE CITY OF MAYSVILLE, GEORGIA, TO PROVIDE FOR THE OFFENSE OF FAILURE TO APPEAR AND FINE AMOUNT THERETO; TO PROVIDE FOR COURT COSTS; REPEAL CONFLICTING ORDINANCES; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES

WHEREAS, the City of Maysville, Georgia is a municipality duly constituted and existing pursuant to Georgia law; and

WHEREAS, the City desires to adopt a set fee schedule for the criminal offense of "Failure to Appear" under O.C.G.A. §40-13-63 and added to the City's "Schedule of Fine" and to adopt a fee schedule for "Court Costs"; and

WHEREAS, the efficiency of the Municipal Court of Maysville, Georgia will be positively affected by the adoption of this Ordinance; and

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED by the Mayor and Council of the City of Maysville, by the lawful authority vested in them, that the City's "Schedule of Fines" is hereby amended as adding the following:
